

#### **Product Environmental Profile – PEP**

#### **Product overview**

The main purpose of the Rack Rail Kit product range is to provide the support structure for attaching APC Uninterruptible Power Supplies (UPSs) into Racks and Enclosures.

The functional unit: provision of support for an UPS unit (weighing between 13 kg to 110 kg) within a server rack or enclosure for 20 years

This range consists of rack rail kits supporting13 kg to 110 kg UPSs at a minimum to 110 kg to 150 kg UPSs at a maxiumum. Products included in the Range are: SURTRK(X), SRTRK(X), IBMRK(X), RWRTRK(X), NECRTRK(X) where X is a number between 1-20, AP9625, SRAILKIT, SPRK60KG-2U, SPRK100KG-3U, 0H-0315, 0M-1012A, 0J-0M-1012A, 0J-0082, 0J-0083, 0M-1876.2, 0M-8208, 0M-8833A and RWDR001.


The representative product used for the analysis is the Smart-UPS Rail Kits (SURTRK).

The environmental impacts of this referenced product are representative of the impacts of the other products of the range which are developed with a similar technology.

The environmental analysis was performed in conformity with ISO 14040.

### **Constituent materials**

The mass of the product range is from 3,000 g and 6,925 g including packaging. It is 5,657 g for the Smart-UPS Rail Kits (SURTRK). The constituent materials are distributed as follows:



## **Substance assessment**

Products of this range are designed in conformity with the requirements of the European RoHS Directive 2011/65/EU and do not contain, or only contain in the authorised proportions, lead, mercury, cadmium, hexavalent chromium or flame retardants (polybrominated biphenyls - PBB, polybrominated diphenyl ethers - PBDE) as mentioned in the Directive

# Manufacturing

The Rack Rail Kit product range is manufactured at a Schneider Electric production site on which an ISO14001 certified environmental management system has been established.

## **Distribution**

#### **Product Environmental Profile – PEP**

The weight and volume of the packaging have been optimized, based on the European Union's packaging directive. The Smart-UPS Rail Kits packaging weight is 989 g. It consists of list 952 g cardboard, 23 g paper and 14 g polyethylene.

The product distribution flows have been optimised by setting up local distribution centres close to the market areas.

#### Use

The products of the Rack Rail Kit product range do not generate environmental pollution (noise, emissions) requiring special precautionary measures in standard use.

This product does not consume electrical power

The product range does not require special maintenance operations.

#### End of life

At end of life, the products in the Rack Rail Kit product range have been optimized to decrease the amount of waste and allow recovery of the product components and materials.

This product range doesn't need any special end-of-life treatment. According to countries' practices this product can enter the usual end-of-life treatment process.

The recyclability potential of the products has been evaluated using the "ECO DEEE recyclability and recoverability calculation method" (version V1, 20 Sep. 2008 presented to the French Agency for Environment and Energy Management: ADEME).

According to this method, the potential recyclability ratio without packaging is: 95%.

As described in the recyclability calculation method this ratio includes only metals and plastics which have proven industrial recycling processes.

## **Environmental impacts**

Life cycle assessment has been performed on the following life cycle phases: Materials and Manufacturing (M), Distribution (D), Installation (I) Use (U), and End of life (E).

Modeling hypothesis and method:

- The calculation was performed on Smart-UPS Rail Kits (SURTRK) product.
- Product packaging is included.
- Installation components: no special components included.
- Scenario for the Use phase: this product range is included in the category 3 enclosures of the PSR0005. Assumed service lifetime is 20 years and use scenario does not involve any electricity use or consumables.
- The geographical representative area for the assessment is European and the electrical power model used for calculation is not applicable.
- End of life impacts are based on a worst case transport distance to the recycling plant (1000km)

Life cycle assessment has been performed with the EIME software (Environmental Impact and Management Explorer), version 5 and with its database version CODDE-2015-04.

The manufacturing phase is the life cycle phase which has the greatest impact on the majority of environmental indicators.

This product range benefits from an eco-design process which is utilized in the design of all products. A design scorecard is generated for all new products to assist engineers in deploying eco-design and then comparing the design features of the new product against the previous version of the product. which help reduce its impacts on the environment.

According to this environmental analysis, proportionality rules may be used to evaluate the impacts of other products of this range: Across all impact categories impacts of other products in this family may be proportional extrapolated based on the ratio of the product mass to that of the reference product mass. The impacts for installation and use are zero across all products in the family.

As the products of the range are designed in accordance with the European RoHS Directive 2011/65/EU, they can be incorporated without any restriction in an assembly or an installation subject to this Directive.
